**1. PERFORMANCE WORK STATEMENT**

The purpose of this Indefinite Deliver Indefinite Quantity (IDIQ) firm fixed price contract is for clearance expeditor/agent services to clear inbound and outbound diplomatic pouches to and from Chhatrapati Shivaji Maharaj International Airport Cargo and deliver to U.S. Consulate General Mumbai located at C-49, G Block, Bandra Kurla Complex, Bandra East, Mumbai 400051, India. The contractor shall be notified not less than 24 hours in advance as to how many pouches are to be picked up. Estimated pickup frequency is three times a week, 52 weeks a year with an average pickup of 500 kgs (in pouches). Additional diplomatic pouch pickups or increase in weight to be shipped may be required on an ad hoc basis.

The contract will be for a one-year period from the date of the contract award, with 1 (one) one-year option.

The contractor shall provide labor sufficient to accomplish the complete movement of all inbound and outbound diplomatic pouch shipments. This includes loading and offloading the diplomatic pouches. (Consulate experience is it usually takes three individuals and the normal time frame to accomplish a standard shipment will take four to six hours).

The contractor shall provide all personnel, equipment, tools, materials, supervision, and other items and services necessary to perform the Courier Services; delivery and pickup of diplomatic pouches as described for US Consulate General Mumbai, India.

1. The Contractor shall be responsible for timely and satisfactory delivery of diplomatic pouches as described below. All services under this contract are to be provided on a fixed price (per Kilogram) basis.

2. Retrieve INBOUND diplomatic pouches and deliver to U.S. Consulate General Mumbai located at C-49, G Block, Bandra Kurla Complex, Bandra East, Mumbai 400051, India. The contractor shall be notified not less than 24 hours in advance as to how many pouches are to be picked up. Estimated pickup frequency is three times a week, 52 weeks a year with an average pickup of 500 kgs (in pouches). Additional diplomatic pouch pickups or increase in weight to be shipped may be required on an ad hoc basis.

Diplomatic Pouch and Mail (DPM) center in Washington, D. C. sends shipments to post twice on Monday and Friday via an international flight carrier. AMEMBASSY New Delhi, sends shipments three times a week via domestic flight carrier. The specifics of the airline carrier and flight details will be communicated to the contractor on a regular basis. In case there is a holiday on these days then it arrives the next day.

3. Pickup OUTGOING diplomatic pouches from the U.S. Consulate General Mumbai located at C-49, G Block, Bandra Kurla Complex, Bandra East, Mumbai 400051, India. and ship via air to Department of State, DPM Answer person, 44132 Mercure Circle, SA-32, Sterling Virginia – 20166, USA, and any other destination as requested. The Contractor shall be notified 24 hours in advance how many pouches are to be picked up and will provide Consulate with Airway Bill number for shipment tracking. Estimated pickup frequency is bi-weekly, 26 weeks a year with an average pickup of 5000 kgs (in pouches). Additional diplomatic pouch pickups or increase in weight to be shipped may be required on an ad hoc basis.
4. The Contractor shall control and provide confidentiality and security for all shipments transported.
5. The Contractor shall get tarmac access at Chhatrapati Shivaji International Airport Cargo for their vehicles and staff that will be used to pick-up and deliver the pouches.
6. The Contractor shall be expected to use the same pool of trucks for all pickups and deliveries. If there will be any change of vehicle, they should notify the Contracting Office Representative.
7. The contractor shall provide a monthly summarized electronic billing and provide detailed reports showing the total amount of shipments and the charges for each. The Contractor shall also provide a quarterly quality service report. This report shall describe the level of service obtained for each shipment to include, at a minimum, the actual pick-up and delivery service times.
8. The Contractor shall immediately notify US Consulate General Mumbai located at C-49, G Block, Bandra Kurla Complex, Bandra East, Mumbai 400051, India. of any potential delay. Notifications should be sent to [mumbaimailroomstaff@state.gov](mailto:mumbaimailroomstaff@state.gov) as well as a phone call to designated Consulate personnel.
9. The Contractor shall perform services Monday through Thursday from 8:00 am to 15:30 pm, Friday 8:00 am to 11:30 am, except U.S. Government and Mumbai Government legal holidays.
10. Costs of Operation. All costs of operation under this contract shall be borne by the Contractor, including, but not limited to tolls, licenses and costs of overtime.
11. Safety and Environmental Precautions. The Contractor shall comply with applicable industry standards and practices for safety to perform the services in the contract. The Contractor's personnel shall take all reasonable steps and precautions to prevent accidents during the performance. The Contractor shall also comply with applicable environmental precautions.
12. The Contractor shall be required to operate a customs bond to enable the clearance of shipments consigned to the US Consulate General, under bond, not to exceed US\$5,000 Bond in Force (BIF).

**MINIMUM AND MAXIMUM AMOUNTS.**

During this contract term, the Government shall place orders totaling a minimum of eight (8) pick-ups of pouches. This reflects the contract minimum for each contract term. The amount of all orders shall not exceed 312 pick-ups of pouches. This reflects the contract maximum for each contract term.

The estimated amounts are based on total estimated Government requirements. This means that if more than one award is made, the estimated amount of work awarded under task order(s) to any single contractor will be less than the amount shown.

Individual purchases shall be documented as follows: The Contracting Officer must obligate the funds via a task order.

**PERIOD OF PERFORMANCE**

After contract award and submission of acceptable insurance certificates, the Contracting Officer shall issue a Notice to Proceed. The Notice to Proceed will establish a date (a minimum of ten (10) days from date of contract award unless the Contractor agrees to an earlier date) on which performance shall start.

**2. PRICING**

The rates below shall include all direct and indirect costs, insurance (see FAR 52.228-4 and 52.228-5), overhead, and profit. The prices include all expenses and materials required to complete the work.

The Government will not consider any claim for any additional compensation unless it has been authorized by the Government in writing in advance. The Government shall not be responsible for any work performed that is not specifically provided for under this contract or authorized by the Government in writing in advance.

### 3. VALUE ADDED TAX

VALUE ADDED TAX (VAT): The Contractor shall include Goods and Services Tax (GST) as a separate line item while submitting their quote and invoice.

### 4. ORDERS

All requests for shipments or performance of individual jobs under this contract shall be issued via an order placed by the Contracting Officer. This task order will contain the following information:

- a) Name of contractor
- b) Contract number
- c) Date of purchase
- d) Purchase number
- e) Name of person placing order
- f) Itemized list of shipment and services furnished
- g) Quantity, unit price, and total price of each item or service, less applicable discounts

Orders may be placed orally initially but must be followed up in writing within 48 hours via issuance of a Task Order. Only a Contracting Officer may place an order, either orally or in writing.

Invoices shall clearly identify details of all charges.

### 5. DETAILED BILLING

The monthly lists of packages and airway bills shall be forwarded to the Contracting Officer's Representative (COR) until the end of each current month for the previous month to the following address:

### 6. INVOICING

(a) The Contractor shall submit monthly invoices to the Embassy financial office at the email address shown in paragraph (c) below. A proper invoice must include the following information:

- Contractor's name and bank account information for payments by wire transfers
- Invoice Date

- Contract number
- A summary showing a listing of each line with total monthly price in local currency for that line. A detailed invoice for each agency has to be attached to each summary invoice and should include the cost breakdown by weight according to the pricing schedule
- A detailed list of all the packages
- Prompt payment discount, if any
- Name, title, phone number, and address of person to contact in case of defective invoice

(b) If an invoice does not contain the above information, the Government reserves the right to reject the invoice as improper and return it to the Contractor within 7 calendar days. The Contractor must then submit a proper invoice.

(d) Payment shall be made in local currency by Electronic Funds Transfer (EFT) within 30 days after receipt of the proper invoice.

**7. KEY PERSONNEL**

7.1 The Contractor shall assign to this contract to the following key person:

POSITION/FUNCTION: Project Manager/Liaison to the US Consulate.

The Project Manager shall have relevant experience in courier services and Level 3 English language proficiency.

7.2 During the first 90 days of performance, the Contractor shall make no substitutions of key personnel unless the substitution is required due to illness, death, or termination of employment. The Contractor shall notify the Contracting Officer within 15 calendar days after the occurrence of any of these events and provide the information required below to the Contracting Officer at least 15 days before making any permanent substitutions.

7.3 After the first 90 days of performance, the Contractor may substitute a key person if the contractor determines that it is necessary. The Contractor shall notify the Contracting Officer of the proposed action immediately. Prior to making the substitution, the Contractor will provide the information required below to the Contracting Officer.

7.4 The Contractor shall provide a detailed explanation of the circumstances requiring the proposed substitution, a complete resume for the proposed substitute. The proposed substitute shall possess qualifications comparable to the original key person. The Contracting Officer will

notify the Contractor of its approval or disapproval of the substitution within 15 calendar days after receiving the required information. The Government will modify the contract to reflect any changes in key personnel.

**8. PERMITS**

Without additional cost to the Government, the Contractor shall obtain all permits, licenses, and appointments required for the work under this contract. The contractor shall obtain these permits, licenses, and appointments in compliance with applicable Indian laws.

**9. RESERVED**

**10. DISCLOSURE OF INFORMATION**

Any information made available to the Contractor by the Government shall be used only for the purpose of carrying out the provisions of this contract and shall not be divulged or made known in any manner to any person except as may be necessary in the performance of the contract.

**11. TASK ORDERS**

The Contracting Officer will issue task orders to order courier services to the Contractor for performance of work under this contract. If an order is given orally, it will be followed up by a written delivery order within 48 hours.

**12. QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)**

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

(a) Minimum order. When the Government requires supplies or services covered by this contract in an amount of less than **5 Kgs**, the Government is not obligated to purchase, nor is the Contractor obligated to furnish, those supplies or services under the contract.

(b) Maximum order. The Contractor is not obligated to honor--

(1) Any order for a single item in excess of than **30 Kgs each**;

(2) Any order for a combination of items in excess of than **900 bags of 30 kgs each** or

(3) A series of orders from the same ordering office within than **Three days** that together call for quantities exceeding the limitation in subparagraph (1) or (2) above.

(c) If this is a requirements contract (i.e., includes the Requirement clause at subsection 52.216-21 of the Federal Acquisition Regulation (FAR)), the Government is not required to order a part of any one requirement from the Contractor if that requirement exceeds the maximum-order limitations in paragraph (b) above.

(a) Minimum order. When the Government requires supplies or services covered by this contract in an amount of less than the 1KG, the Government is not obligated to purchase, nor is the Contractor obligated to furnish, those supplies or services under the contract.

(b) Maximum order. The Contractor is not obligated to honor--

(2) Any order for a single item in excess of ;-

Maximum Air Freight - Import = 1000 KG  
Maximum Air Freight – Export = 200 KG

(3) Any order for a combination of items in excess of the estimated amount; or

52.229-11 Tax on Certain Foreign Procurements—Notice and Representation (JUN 2020)

(a) *Definitions*. As used in this provision—

*Foreign person* means any person other than a United States person.

*Specified Federal procurement payment* means any payment made pursuant to a contract with a foreign contracting party that is for goods, manufactured or produced, or services provided in a foreign country that is not a party to an international procurement agreement with the United States. For purposes of the prior sentence, a foreign country does not include an outlying area.

*United States person* as defined in 26 U.S.C. 7701(a)(30) means—

(1) A citizen or resident of the United States;

(2) A domestic partnership;

(3) A domestic corporation;

(4) Any estate (other than a foreign estate, within the meaning of 26 U.S.C. 701(a)(31)); and

(5) Any trust if—

(i) A court within the United States is able to exercise primary supervision over the administration of the trust; and

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). The Offeror would claim an exemption from the withholding by using the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, available via the internet at [www.irs.gov/w14](http://www.irs.gov/w14). Any exemption claimed and self-certified on the IRS Form W-14 is subject to audit by the IRS. Any disputes regarding the imposition and collection of the 26 U.S.C. 5000C tax are adjudicated by the IRS as the 26 U.S.C. 5000C tax is a tax matter, not a contract issue. The IRS Form W-14 is provided to the acquiring agency rather than to the IRS.

(d) For purposes of withholding under 26 U.S.C. 5000C, the Offeror represents that—

(1) It  is  is not a foreign person; and

(2) If the Offeror indicates “is” in paragraph (d)(1) of this provision, then the Offeror represents that—I am claiming on the IRS Form W-14  a full exemption, or  partial or no exemption [*Offeror shall select one*] from the excise tax.
