SAFETY AND HEALTH REQUIREMENTS *(All USG Projects require the use of appropriate Safety gear!)*

The **Contractor** shall be responsible for all damages to persons or property that occur as a result of the Contractor's fault or negligence, and shall take proper safety and health precautions to protect the work, the workers, the public, and the property of others.

For these purposes, the contractor shall:

1. Provide appropriate safety barricades, signs, and signal lights **AS NEEDED DEPENDING ON THE NATURE OF WORK. DETAILS GIVEN BELOW ARE INDICATIVE AND MANDATORY. CONTRACTOR MAY TAKE ADDITIONAL PRECAUTION AS NEEDED DEPENDING ON THE NATURE OF WORK.**
2. Comply with the standards issued by any local government authority having jurisdiction over occupational health and safety issues; and,
3. Ensure that any additional measures the contracting officer determines to be reasonably necessary for this purpose are taken.

MONITOR DUTIES
